# The History of the HCCF

There is a slogan that community foundations in Michigan use: "For good, for ever." That is because community foundations date back all the way to 1914 – yes, before the Great Depression. Banker and lawyer Frederick Harris Goff formed that first community foundation as the Cleveland Community Foundation.

The history of the Huron County Community Foundation is much shorter, but it has weathered the ebb and flow of changes in the economic climate.

Carl Osentoski, executive director of the Huron County Economic Development Corp, met with businessman Lowell McDonald informally and the two men discussed a dream of having a community foundation in Huron County. The concept was transformed into action when Martha Thuemmel of Port Austin, then county commissioner, came forth with \$1,000 of seed money.

It wasn't until the Kellogg Foundation of Battle Creek, however, offered grant dollars to community foundations that real growth bloomed. The goal of the HCCF was to raise \$400,000 to receive a grant of \$200,000. S. Tenney McGraw, a

retired banker, launched an aggressive campaign to build the HCCF in April of 1997. He served as the first executive director of the Foundation.

Under his guiding hand, and through the generosity of individuals and businesses, the goal was reached. Significant boosts were received from the Huron Medical Center, Scheurer Hospital, the estate of Judge Neil MacCallum and Vernetta Thuemmel.

The Kellogg grant required the formation of a Youth Advisory Committee that would oversee the grant funds received so that the youth of the area would benefit. YAC continues to meet monthly during the school year, conducting grant rounds annually.

The HCCF complies with the National Standards of Community Foundations and those who place funds under its care are assured of careful, conscientious handling of the funds and it, like the Cleveland Community Foundation, will serve the county for generations now and to come thanks to the many contributors who want to improve the quality of life in Huron County.

Two very valuable people left the foundation last year. Jane Mayes left her role on the grantmaking committee. We will miss her perspective and insight into what community needs can be met. She was particularly supportive of the arts, culture, and education. Jeanette Hagen served on the Board of Trustees and acted as the YAC advisor for several years. If there ever was a perfect match for a youth mentor, it would be Jeanette. The "YACers" really liked and admired her. They will miss her leadership, commitment and enthusiasm.

We welcomed two new community members to the Foundation last year. Rodney Terwilliger has returned to Bad Axe and has been appointed the new YAC advisor. He has an extensive background in mentoring young people and building community support for youth activities. Kelly Jo Osentoski has filled the vacancy on the grant-

making committee. Her community involvement gives her a unique insight into our needs. Besides, she makes a great carrot cake (as we learned at Bidders Bash)! Both Rodney and Kelly Jo are wonderful people who are committed to making things better in this community and I look forward to working with both of them.

Three new scholarship funds were established since my last message: the Sara Elizabeth Wood Scholarship Fund, the Charlotte Talaski Family Scholarship Fund, and the Charles and Roseline Gliniecki Memorial Scholarship Fund. You can read more about them in this report.

The Foundation again conducted three fundraisers to support operating expenses. These fundraisers are necessary in order to preserve the principal of endowments. The Foundation's administrative fee structure is kept as low as possible so that fund balances will grow as rapidly as possible and additional funds are needed to meet everyday operating expenses. We held our fifth annual golf outing in May at Verona Hills Golf Club. We held our second Bidders Bash silent/live auction event in October at the Franklin Inn. It was a delightful, funny, and exciting evening. We also conducted our annual Cornerstone Club support drive this fall. All were very successful, thanks to the solid community support we received, for which the Foundation is very grateful.

The goal of the Foundation is to support the community by making funds available for educational scholarships and community projects. This year the Foundation awarded \$26,100 in scholarships and \$13,401.96 in project grants. Also, the YAC raised funds at Cardboard City and at a barbeque sandwich sale which were donated to the Huron County Homeless Coalition fund.

This year the Foundation decided to reach out to the community and provide estate planning information. We held our first estate planning seminar in September. Attorney Donald Clark presented a very valuable overview of the estate planning process and the issues involved. The people who attended appreciated the information and felt that the evening had been very helpful. The Foundation plans on having another seminar next

This past year has been a real roller coaster ride in the stock market. There were moments when I got a bit nervous about the short term effect of the market's volatility. Thanks to our

managed investment account and our asset management committee we stayed the course in our policy of a target of 60/40 and came out at the end of our fiscal year on a positive level from the last year.

In May of this year, as part of its tax reform legislation, the State of Michigan eliminated effective January 1, 2012, the special Michigan income tax credit for contributions to permanent endowment funds with the **Huron County Community** Foundation.

There are naysayers who believe that once the Michigan income tax credit for contributions to non-profit institutions expires, charitable giving will decrease. I personally don't think that will be the case. I have found in working with the HCCF that the tax credit was a bonus for giving but not the incentive to do so. I think people support a charitable organization because they believe in its mission and the good being done and they want to do their part.

It's been a good year. I look forward to the next.





# Youth Advisory Committee

The Youth Advisory Committee (YAC) is part of the Huron County Community Foundation and is dedicated to the youth of the county. It is comprised of students from schools in Huron County who work with adult advisors to put kids first. YAC meets for a half day once a month.

YAC reviews grant applications and makes recommendations to the Board of Trustees of the Foundation for projects that have a positive impact of the youth of the county.

YAC also teaches youth the value of philanthropy, fosters leadership qualities, heightens awareness of community needs, and takes a positive approach to improving the quality of life.

Meetings of YAC involved leadership speakers, evaluating its fund balance, planning projects and fundraisers, and preparing for the recruitment of new members.

This year YAC conducted its annual "Cardboard City" project, the purpose of which was to raise community awareness of the problem of homelessness in our county especially as it impacts young people. YAC members gathered on the County Building lawn in

November and spent the cold evening in cardboard boxes which



# **HCCF Grants 2011**

The Huron County Community Foundation has again this year supported the community by making its 2011 grant awards. Foundation grants are made to charitable organizations in the county to meet pressing community needs. Grant awards totaled \$13,401.96 and include the following:

\$5,000.00 was awarded to the Sacred Heart Church from the Dr. Edward and Alice Steinhardt Sacred Heart Church Designated Fund.

\$2,000.00 was awarded from the Foundation's Education and Literacy Field of Interest Fund and the Foundation's Community Trust Fund to the Traveling Book Tote program of the HISD which makes quality books and math/science and language art books available for youngsters to take home.

\$1,100.00 was awarded from the Foundation's Charles and Judith Weeks Donor Advised Fund and the Foundation's Community Trust Fund to the North Huron Schools Industry Technology Department for the purchase of tools and materials for its woodworking and pre-engineering classes.

\$1,500.00 was awarded from the Foundation's Huron Medical Center Medical Health Field of Interest Fund to the Huron Medical Center's Breastfeeding and Parenting Program which provides packets to assist women in breastfeeding.

\$1,729.00 was awarded from the Foundation's Huron Medical Center Medical Health Field of Interest Fund to Care and Share/Michigan Food Bank to assist in feeding approximately 250 needy families in the county.

\$1000.00 was awarded from the Foundation's Huron Medical Center Medical Health Field of Interest Fund to Project Connect/Huron County Homeless Coalition for the purpose of purchasing cleaning and hygiene baskets.

\$279.96 was awarded from the Foundation's Arts and Culture Field of Interest Fund to the Port Austin Historical Society to help in the purchase of a tent and video equipment.

\$600.00 was awarded from the Foundation's Health and Medicine Field of Interest Fund to Scheurer Hospital to support health screening at its Health Fair.

\$265.00 was awarded from the Foundation's Natural Resources Field of Interest Fund to Huron County 4-H/MSU Extension to support its 4-H camp.

Youth Advisory Committee funding must benefit the youth of Huron County in some way. The YAC\* students typically make awards two times per school year.

The Huron County Community
Foundation accepts applications for a wide field of interests, from education, arts & culture, and health to recreation resources, and natural area preservation.

Those with 501 (c) (3) status, or groups that fall under another organization with that classification, are considered for grant awards. Routine operating expenses, capital equipment, computer hardware or software, vehicles, endowment campaigns, expenses normally covered by municipal government, debt obligations are not grant fundable.
