The Youth Advisory Committee (YAC) is part of the Huron County Community Foundation and is dedicated to the youth of the county. It is comprised of students from schools in Huron County who work with adult advisors to put kids first. YAC meets for a half day once a month.

YAC reviews grant applications and makes recommendations to the Board of Trustees of the Foundation for projects that have a positive impact on the youth of the county.

YAC also teaches youth the value of philanthropy, fosters leadership qualities, heightens awareness of community needs, and takes a positive approach to improving the quality of life.

In January, YAC members participated in **National Mentoring Month** by reading the book, Martin's Big Words, at North Huron Elementary School and Owen-Gage Elementary School.

In March, YAC'ers held a BBQ Beef Sandwich fundraiser at McDonald's Food & Family Center. Proceeds from the event "BBQ for Books" went to support the **Huron Country Traveling Book Tote Project.** A total of \$250 was raised for this project which is estimated to serve over 300 preschoolers throughout the county.

YAC members participated in "Embrace Our Earth" Earth-Day event by conducting their annual food-drive competition. A total of 367 lbs. of non-perishable food was raised with another \$250 donated to the Caseville Food Pantry. North Huron High School won this year's competition by raising the most donated food, receiving the winner's banner and an ice-cream party for the school

The annual "Cardboard City" project is designed to raise community awareness of the problem of homelessness in our county especially as it

impacts young people. YAC members gathered on the County Building lawn in November and spent the cold evening in cardboard boxes which they had built into shelters. The event raised funds

which were

donated to the Huron County Homeless Coalition fund.


YAC also awarded grants which focus on benefits to youth. Recipients included Great Start Collaborative of HISD (\$500) for the project, "Family Fitness Fun!"; Huron County Rural Schools (\$379) for the project, "Pennies for the Rural Schools"; Huron Intermediate School District's Huron Learning Center (\$750) for the project, "Traveling Book Tote Project"; and the Pigeon District Library (\$300) for the project, "E-Books for Youth". It is estimated that these projects will collectively serve approximately 9,800 children, teenagers, and families across the county.





2012 GRANT AWARDS

Youth Advisory Committee funding must benefit the youth of Huron County in some way. The YAC students typically make awards two times per school year.

The Huron County Community Foundation accepts applications for a wide field of interests, from education, arts & culture, and health to recreation resources, and natural area preservation.

Those with 501 (c) (3) status, or groups that fall under another organization with that classification, are considered for grant awards. Routine operating expenses, capital equipment, computer hardware or software, vehicles, endowment campaigns, expenses normally covered by municipal government, debt obligations are not grant fundable.

MEW FUNDS

The Saginaw Basin Land Conservancy Fund

Last summer, the Saginaw Basin Land Conservancy created a designated fund with the Foundation.

The Saginaw Basin Land Conservancy helps maintain the quality of life in the Saginaw Bay Watershed through the preservation of important wetlands,

waterways and natural areas for the public benefit. The Conservancy is a non-profit charitable organization working in the Saginaw Basin. To date, the Conservancy has protected more than 5800 acres.

One of the properties preserved by the Saginaw Basin Land Conservancy is the Sand Point Nature Preserve located in Caseville Township, which is an important ecological area on Wild Fowl Bay. Approximately half of the preserve is wetlands, attracting wildlife which includes bald eagles and rare marsh wrens. The Conservancy acquired the land in 2008 and recently expanded it from 139 acres to nearly 180. Trails throughout the property provide opportunities for non-motorized recreation.



Madeline M. Bauer Scholarship Funds

The estate of Madeline M. Bauer has established two scholarship funds with the foundation to honor her memory and commitment to this community.

Madeline was born in Sanilac County. She moved to the Ubly area early in her life. She worked for the REA which is now known as the Thumb Electric Cooperative and became a very active member in her community. She was a lifelong member and officer of the Ubly Library Board and was a very active member of her church, Our Savior Lutheran Church of Bad Axe. She lived close to the Ubly School and became committed to supporting the advanced education of its students. She was also aware of the many benefits the Huron Area Technical Center offers to students who attend that institution.

Madeline died at the age of 95 and established scholarships for students of the Ubly School District and the Huron Area Technical Center in her Last Will and Testament.

The Harbor Beach Community Hospital Foundation Fund

Last spring, the Harbor Beach Community Hospital Foundation created a designated fund with the Foundation.

The fund will provide a means for supporters of the Harbor Beach Hospital Foundation to help build an endowment, knowing that it is a permanent gift that supports all of the good work the hospital provides to the community. All money given to the fund will remain there permanently, with only the interest being returned to the hospital for its use.

Robert Swartz, chairman of the Harbor Beach Community Hospital Foundation, said, "This is another step in the development of our foundation in serving the health needs of Harbor Beach and the surrounding communities."
