YOUTH ADVISORY COMMITTEE

The Youth Advisory Committee (YAC) is part of the Huron County Community Foundation and is dedicated to the youth of the county. It is comprised of students from schools in Huron County who work with adult advisors to put kids first. YAC meets for a half day once a month.

YAC reviews grant applications and makes recommendations to the Board of Trustees of the Foundation for projects that have a positive impact on the youth of the county.

YAC also teaches youth the value of philanthropy, fosters leadership qualities, heightens awareness of community needs, and takes a positive approach to improving the quality of life.

The Foundation is excited to welcome Jeanette Hagen back as the YAC Advisor. She is doing a great job with help from staff supporters Amy Braun and Laura Tyll.

The YACers' annual "Cardboard City" project is designed to raise community awareness of the problem of homelessness in our county especially as it impacts young people. YAC members gathered on the County Building lawn in November and spent the cold evening in cardboard boxes which they had built into shelters. The event raised funds which were donated to the Huron County Homeless Coalition fund.

YAC also awarded grants which focus on benefits to youth. 2012-2013 YAC grant recipients include \$750 to Huron County Sheriff Department for their **Dive Team Trailer** to better serve citizens in emergency situations; \$750 to Huron County Homeless Coalition – **Project Warm** to provide outerwear to children; and \$500 to Huron County MSU Extension for their **Huron County 4-H Camp** to offset cost for Huron County campers.

The Huron County Community Foundation has again this year supported the community in making its 2013 grant awards. Foundation grants are made to charitable organizations in the county to meet pressing community needs. Grant awards totaled \$20,820 and include the following:

- **\$7,500.00 was awarded to the Sacred Heart Church** from the Dr. Edward and Alice Steinhardt Sacred Heart Church Designated Fund.
- **\$3,070.00 was awarded to Harbor Beach Theater** for support of its program to upgrade to a digital theater.
- **\$1,800.00 was awarded to the Suicide Prevention Coalition** for suicide counseling training.
- **\$250.00 was awarded to the Thumb Area Arts & Entertainment Council, Inc.** for support of the Sand-walker Summer Concert Series program.

- **\$4,000.00 was awarded to the MSU Extension office** for a Nutrition Education Program.
- **\$1,400.00 was awarded to the Laker Elementary School** for support of Fine Arts Bridge Generation Program.
- **\$2,000.00 was awarded to the Saginaw Basin Land Conservancy** for support of its Sand Point Nature Preserve Visitor Enhancement Experience Project.
- **\$800.00 was awarded to the Huron Intermediate School District** in support of its Special Olympics Program.

YAC and the Huron County Community Foundation each offer grant rounds during the year. An announcement is posted to the website, www.huroncountycommunityfoundation.org, whenever applications are being accepted. You may also register at the website to receive an email notification of pending grant rounds.

Youth Advisory Committee funding must benefit the youth of Huron County in some way. The YAC students typically make awards two times per school year.

The Huron County Community Foundation accepts applications for a wide field of interests, from education, arts & culture, and health to recreation resources, and natural area preservation.

Those with 501 (c) (3) status, or groups that fall under another organization with that classification, are considered for grant awards. Routine operating expenses, capital equipment, computer hardware or software, vehicles, endowment campaigns, expenses normally covered by municipal government, debt obligations are not grant fundable.

He was the first recipient of this award that acknowledged a physician who dedicated his or her medical talents to rural communities. His wife Jennie had a passion for education and a strong connection to the medical and nursing world. These interests came together to grow the Jennie Oakes Student Nurses Scholarship Fund. Dr. Oakes honored his wife's memory and their commitment to the rural lifestyle with this fund.

The scholarship now supports a nursing student from the Harbor Beach Community Hospital service area. The Oakes family hope was that other young people would get their education and bring their nursing talent back to Harbor Beach. The fund has continued to grow over the years through donations from the Oakes family and others. The administration of the scholarship has been handled by the Harbor Beach Community Hospital and has now passed to the Huron County Community Foundation to grow and prosper for good...for ever.
